## 1. Introduction

Go2Fish is a memory game yet challenging and rewarding. The goal is to match 2 cards that are the same from the deck of 48 cards. Each time you match a pair a portion of the picture is revealed. The goal is to remove all the cards in as few moves and quickest time as possible. There are six total game sets in Go2Fish. Each game set has 10 different picture puzzles.

Go2Fish is compatible with Secure Digital, Compact Flash, Multimedia Card and Sony Memory Stick. Go2Fish requires PalmOS® 5.0 and higher. Sound is only available on the Palm® Tungsten T, C and Palm® Z71 only.

## 2. System Requirement

- PalmOS® 5.0 and higher
- Sony Color Clie (320 x 320)
- 150K of main memory
- 1.5 Meg for each game set. There are 6 game sets. Game sets can be moved to the card.

### 2.1 Compatibility

- Palm® Tungsten T, Palm® Tungsten W, Palm® Tungsten C, Palm® Zire 71,
- Sony Color Clie

## 3. Installation

### 3.1 Main Program

To install Go2Fish™ double click on the file Go2Fish.prc.

### 3.2 Game Sets

To install a game set double click on the file Go2FishX1.pdb and then press the HotSync® button on the cradle. The HotSync® manager will install the files on to your Palm. You can install all the game sets if you like. You can also set the game set destination to the card to save you RAM.

#### 3.2.1 Palm Tungsten T, C, Z71 or Any PalmOS 5.x

If you have a Palm Tungsten T, C, Z71 or any PalmOS 5.x Palm then use the game sets in the **PalmOS5** folder.

### 3.2.2 Sony Clie


If you have Sony Clie running PalmOS® 3.5 or 4.x then use the game sets in the **SonyClie** folder. If you have Sony NX, NZ or newer Palms then use the **PalmOS5** folder version.

## 4. Launching Go2Fish™



From your Launcher look for the icon **Go2Fish** and tap on it to launch it. If you cannot find the icon use the scroll bar and scroll down.

## 5. User Interface



When you tap on a card, the card will be revealed. If a match is found then the card is discarded and a portion of the picture is revealed.

When you have removed all the cards the game ends and the next puzzle will be shown.

When showing the completed picture tap on the screen to continue.

## 6. Options



If you select a new game set a new game will be started.

Sound FX is only available on Palm® Tungsten T, C and Palm® Z71 only.

## 7. Security

Go2Fish offers a very non-secure password. The password is stored in the Saved Preference database under id "FISH". The password is not encrypted. It is in plaintext.

From the Options menu select the Security... menu item.



When you set a password each time you launch Go2Fish you will be prompted for your password. If you get it wrong three times then you will return to the launcher.

If you had forgotten your password you have two choices.

1. From the Launcher select Delete from the App menu and delete Go2Fish and reinstall Go2Fish.
2. Use a resource editor and open the Saved Preference and look for the ID FISH and delete it

The password feature is there to protect other people from accidentally launching Go2Fish. This also prevents minors from launching Go2Fish.

## 8. External Card Support

When you install the game sets you can set the destination to the card. The game sets will be installed to the card in /Palm/Launcher folder.

You can also manually use a file manager such myWorkbench ([www.toysoft.ca](http://www.toysoft.ca)) to move the game sets to the card folder /Palm/Launcher.

## 9. Additional Game Sets

Currently there are only two game sets available. More game sets will be posted on our website [www.toysoft.ca/go2fishx.html](http://www.toysoft.ca/go2fishx.html). You will also be email about the availability of new game sets.
